TERMINATION OF MEMBERSHIP:

1. Upon resignation by the member and acceptance by the executive committee.
2. The annual subscription fees of a member shall become due on 1st April each year. If the subscription is not paid until 1st June the member will be deemed to be a defaulter and the membership will be ceased. There will be a penalty of INR 500 per month for every default month to renew the membership.
3. Any member who causes any harm or prejudice to the association or who doesn't comply with the rules and regulations of the association may be expelled from the membership of the association by resolution of the executive committee on voting basis.
